King Living x Niramaya Employees Offer: Terms and Conditions

1. These Terms and Conditions apply to the products which are offered by King Living as part of the **King Living x Niramaya Employees Offer** (the **Offer**).
2. The **Discount** is: *up to* 50% off the Full Price or Total Value Price.
3. **LOWER PRICE GUARANTEE**: If a separate promotional offer applies to a King Living product which is eligible for the Discount, and the promotional price of that product is equal to or lower than the price of that product when the Discount is applied, the Discount for that product is instead 10% off the promotional price.
4. **Niramaya** means the residential villa community known as Niramaya Villas and Spa, located at 1 Bale Drive, Port Douglas, Queensland 4877.
5. **Eligible Customer** means a person who, at the time that person finalises their order, is either:
 - (a) employed to work at Niramaya; or
 - (b) employed by the operator of Niramaya in a role which is wholly or principally concerned with Niramaya, including in a marketing, sales, reservations or administrative capacity, whether or not that person works at Niramaya.

King Living may confirm in writing that a particular role, is within this clause. A person whose employment has ended is not an Eligible Customer.
6. **Exclusions**: The Offer is not redeemable: (i) at any King OUTLET sales venue; or (ii) in connection with the purchase of Clearance Products; or (iii) in connection with the purchase of King FreeForm Products; or (iv) in connection with a King Trade transaction (the **Exclusions**).
7. The Offer means that an Eligible Customer can receive the nominated Discount off the Full Price or Total Value of a King Living product (excluding the **Exclusions**), subject to these Terms and Conditions.
8. **Proof of Eligibility**: A customer must provide proof that they are an Eligible Customer at the time of purchase. King Living accepts a current staff identification card, a recent payslip, a letter or email from the customer's employer confirming their current employment, or any other form of proof which King Living considers satisfactory. King Living may decline to apply the Discount where satisfactory Proof of Eligibility is not provided.
9. The Offer:
 - 11.1 starts on Monday, 24 August 2026 and ends at close of business on Thursday, 31 December 2026 (the **Term**);
 - 11.2 is limited to King Living products offered for sale in King Living showrooms in Australia;
 - 11.3 is **not** available to online customers;
 - 11.4 is limited to products purchased by the Eligible Customer for their own domestic and personal use, and not for any commercial purpose;
 - 11.5 does not apply to delivery fees or service charges; and
 - 11.6 cannot be retrospectively applied to a previous order and cannot be used in conjunction with any other promotion, discount or promo code, except as provided in clause 3.

- 12 A customer must present Proof of Eligibility when they attend the King Living showroom to finalise their order.
- 13 The Discount will be applied to the same, single transaction. Discount cannot be deferred to another transaction or aggregated across transactions.
- 14 This Offer can be used be redeemed only once, per Eligible Customer during the Term.
- 15 Offer cannot be re-sold or re-issued and is not redeemable for cash or credit.
- 16 King Living reserves the right to change, alter or end the Offer at any time.
